1- Usage Area / Indications

PRORCD is used as an antiseptic in root canal treatment. It is indicated for the removal and cleaning of residual tissue and necrotic material in root canal treatment. It is a powerful antiseptic.

2- Usage

The product is impregnated with cotton or similar fibrous material and placed in the treatment area. After waiting for a while, the cotton is removed, and the treatment is continued.

3- Contraindications

Do not use in patients with hypersensitivity to its ingredients.

4- Side effects

If it leaks into living tissue, it may cause irritation and tissue damage. Formaldehyde compounds do not remain within the pulp boundaries but may infiltrate into soft and hard tissues, causing nerve destruction, allergic responses, paresthesia, and localized

In case of contact with oral tissue, eyes, or skin, immediately clean the area with plenty of water. Use with a rubber dam to prevent it from touching the mucosa. It can only be used by professional dentist.

6- Storage conditions:

Store at room temperature between $5^{\circ}C - 30^{\circ}C$ as recommended. Protect from moisture and extreme heat and cold. The period of use is 2 years from the date of manufacture.
