#### **PROCANAL G**

#### 1- Description

PROCANAL G is an endodontic cement used with gutta-percha cones to fill the root canal. It has bactericidal properties and is homogeneously mixed to achieve a creamy consistency that facilitates easy placement of gutta-percha in the canal. The guttapercha ensures adhesion and sealing within the canal. It does not dissolve after application, does not discolor the tooth, and can be easily removed. It is radiopaque.

#### 2- Usage Area / Indications

PROCANAL G is used as an intracanal filling material in endodontic procedures. It is indicated for canal filling techniques using guttapercha cones.

#### 3- Usage

Choose the gutta-percha type. Drop 1-2 drops of the liquid into a mixing glass, add some powder, and mix for 1-2 minutes until a thick, dense, and smooth creamy consistency is achieved. At the ideal density, the spatula will extend about 2 cm when removed from the mass. After completely cementing the gutta-percha, fill the canal according to the appropriate endodontic method.

#### 4- Contraindications

Do not use in patients with hypersensitivity to its ingredients.

#### 5- Side effects

It may cause irritation and has allergenic potential due to the presence of eugenol. It may also cause sedation. Protect the mucosa with a rubber dam during application.

#### 6- Warning:

Although it is well tolerated, special care is recommended to avoid overflow onto the periapical tissue. Use a rubber dam to prevent contact with the mucosa.

#### 7- Storage conditions:

Store at room temperature between  $5^{\circ}C - 30^{\circ}C$ . Protect from moisture, extreme heat, and cold. The product has a shelf life of 2 years from the date of manufacture.
