#### PROFTCH - ACID GEL

### 1- Description

It is a 37% phosphoric acid used for the preparation of enamel and dentin surfaces. Its blue color ensures easy visibility on the surface, and its gel consistency makes it easy to apply.

# 2- Usagearea / Indications

It is used for preparing enamel and dentin surfaces according to the total etch technique. The gel's consistency and color facilitate application and ensure thorough coverage.

# 3- Usage

- Prepare the cavity according to the general instructions for composite restorations.
- Clean and dry the preparation.
- Apply the acid gel to the enamel and dentin to be restored, and leave it on the surface for 15-20 seconds.

# CE

- Rinse the acid gel thoroughly for at least 5 seconds, and remove excess water from the preparation surface by lightly blowing air.
- Ensure that no acid remains on the preparation surface.
- If dealing with fluorotic enamel, it may be necessary to repeat the application steps.
- Apply the bonding system according to the manufacturer's instructions.

#### 4- Contraindications

Do not use in patients with hypersensitivity to its ingredients.

#### 5- Side effects

Due to its high acid content, it may cause irritation in soft tissues such as gums.

# 6- Warning

Use acid-resistant materials, as some floor primers are acid-soluble. It may cause sensitization if it contacts eyes, skin, or mucous membranes; wash the affected area with plenty of water immediately. Use a rubber dam to prevent contact with mucosa. Keep away from children. It is for professional use in dentistry only. Close the syringe after use.
