1. Description

PROAIR F – AIRFLOW Powder is intended solely for use in overgingival treatments.

2. Usage Area / Indications

- For cleaning stains, discoloration, and dental plaque.
- For cleaning plaques before the placement of sealants.
- For removing plaque and stains prior to whitening procedures.
- Effective in cleaning plaque and stains in orthodontic patients.
- Used for cleaning stains in color-tone detection.

3. Usage

4. Contraindications

Do not use in patients with hypersensitivity to its ingredients.

5. Side effects

Patients and users with chronic bronchitis or asthma should not be treated with an air polishing device, as sprayed air and dust can cause breathing difficulties. Avoid use in patients with upper respiratory tract disease. Patients on a low-salt diet (e.g., arterial hypertension) should not be treated with this powder due to its sodium bicarbonate content. The flavors in the powder may cause allergic reactions in some cases. Do not direct the spray powder at fillings, dental crowns, or bridges, as this may damage the repair. Avoid use for subgingival treatments. Both patients and users should wear eye protection. Users must wear a mask. For maximum protection, use long cotton rolls inside the mouth. Utilize your dental unit's unloader at high speed.

6. Warning:

Do not exceed the powder filling limit indicated in the dust container of the device you are using. The powder does not contain granulated sugar. Carefully read the instructions in the manual provided with your device and system and adhere to all safety precautions.



7. Storage conditions

Store in a dark place at room temperature between $5^{\circ}C - 30^{\circ}C$. Protect from moisture, extreme heat, and cold. Close the lid after use to maintain activation. Avoid storing near heat sources or acids. If the bottle is left open, the powder may clump and clog the device.

The product has a shelf life of 2 years from the date of manufacture.

We recommend using the product in accordance with the information and warnings provided in the instructions.
